This event is co-organized by the Konrad Adenauer Foundation in Warsaw. It is part of the research project "Germany and Poland in a Differentiated European Union" funded by the German-Polish Science Foundation

For decades, the European Union (EU) has gradually departed from uniform integration by allowing individual member states to move forward or opt out from selected policy fields. In effect, we now face a considerably fragmented political system in key policy fields. While the question of legitimacy has been extensively debated with regard to the EU's democratic nature, its normative implications of differentiation have for long received little attention.

In this conference, we thus aim to analyse the legitimacy of differentiation across various EU policy fields. By differentiating between a legal, social and normative notion of EU legitimacy, we strive to encourage an interdisciplinary debate on the virtues and vices of further differentiating European integration.

This hybrid conference will be held in English and will be moderated by Dr. Thomas Mehlhausen (Leipzig University).
